## Remarks:

Reference is made to the announcement of the Company dated 27 July 2026. The opening balance of issued shares of the Company as at 30 June 2026 was 19,598,900 H shares and 52,760,000 domestic shares, amounting to a total of 72,358,900 issued shares. Following the Conversion, the number of H shares has increased by 9,286,359 shares, while the number of domestic shares has decreased by 9,286,359 shares. The total number of issued shares of the Company after the Conversion remains unchanged, comprising 28,885,259 H shares and 43,473,641 domestic shares.
